The recent rise in COVID cases has caused Mayor Lightfoot to make changes to City of Chicago restrictions. One of the new guidelines directly affects residential properties located within the City of Chicago, specifically asking residential Property Managers to instruct residents to limit inside gatherings to no more than 5 guest per unit. Security: The Board of Directors approved AGB Security as our new security service for the Cooperative effective July 4th. Members were informed in a special notice delivered by mail. All members are advised to call 911 in an emergency, or if a crime is being committed. If there are concerns of suspicious behavior, violations of London Towne policies or the Occupancy Agreement or a request for an escort to your unit, please contact security at 773-966-6136 identifying yourself as a London Towne Member Owner. All Members are urged to continue to keep porch lights on at night and report lights out to Security or the Management office.

Recycle Fines— Members have expressed concern over rising carrying charges. Have you thought about what we can do cooperatively to keep cost down? An example is the recycle bins. Are you aware that we get fined \$68 per yard for every recycle bin that contains raw garbage or any items that are not considered recyclable? The ONLY items that should be placed in the recycle bins are empty bottles, cans, paper and cardboard. DO NOT include plastic bags, plastic film, or put recyclables inside of plastic bags. No plant material, foods or liquids, no sharp items or electronics should be placed in the recycle container. Help us save thousands of dollars in fines.

Annual Recertification-As a rule, Annual Recertification notification is mailed to Member Owners by September 1st of each year. Due to COVID-19 and the health and safety concerns involved with all, the Board of Directors agreed with Management recommendation to waive recertification for this year and keep current surcharges as is until 2021.

Huddle House-LTH President JoAnn Kenner and Treasurer Sheree Blakemore attended the July 20th Ground Breaking Ceremony for the Huddle House Restaurant that will be located in front of the new Montclare Senior Residences at 9421 S. Stoney Island. It will be the first Huddle House for the City of Chicago, and will provide 80 new jobs. This groundbreaking event was hosted by 8th Ward Alderman Michelle Harris and attended by Mayor Lightfoot, Illinois State Senator Elgie Simms, and Cook County Commissioner Stanley Moore. These government officials have made a commitment to bringing economic development to the south side.
